

Inspired Giving

An Imaginative Solution to an Employment Gap In My Father's House Endowment for Disabilities Ministry

Young adults with special needs, who are between the ages of 18 and 23, can sometimes live in an uneasy state of uncertainty, caught between their high school years and when the State of Maryland's Employment Association will help find them employment. Dr. Barbara Gaver, who has two special-needs children of her own, has seen the toll this gap takes and established the *In My Father's House Endowment for Disabilities Ministry* in the Catholic Community Foundation to close it.

Her idea was for parishes throughout the Archdiocese to employ young adults with disabilities, adding dignity and purpose to those first five years of adulthood, and her fund will help cover their salaries.

Dr. Gaver says, "I think Jesus gave me children who have special needs because he wanted me to

understand firsthand the challenges they face and the struggles they go through. I have two children who were challenged, and I've seen them blossom into happier, more secure young adults when they became employed."

A pilot parish for the program, the Catholic Community of Ascension and St. Augustine (CCASTA), has begun to lead this effort. Since the summer of 2019, CCASTA has employed Paul Jeske, then 19, as a facilities assistant. When asked if the job has changed his life, Paul says, "It helped me get used to the working world and learn what it's like to have a job."

Eventually, Dr. Gaver would like to see the *In My Father's House* fund support catechesis for those with special needs, another area where she feels they are sometimes underserved. But for now, her focus remains on employment.

Cross Estate Planning Off Your To-Do List

A new year will offer a fresh start on your personal goals and resolutions. It's also the perfect time to take stock of where you are in your estate planning.

When surveying your plan, make sure you review the following:

Don't Have an Estate Plan?

It's never too late to plan for the future. Contact us for more information on how you can create an estate plan that provides for you and for the parishes, ministries and programs of the Archdiocese of Baltimore.



Wills and trusts. Review your will or trust for any life change such as a birth, death, marriage or a move to a different state.



Beneficiary designations. Remove any beneficiary on your life insurance or retirement plans who is deceased or is no longer in your life, and consider adding a charitable organization like the Catholic Community Foundation.



Durable power of attorney. Make sure your durable powers of attorney for financial and health care are current. A copy of the financial power of attorney should be given to your family members, while a copy of your health care power of attorney should be provided to both family members and health care providers.



Safe-deposit box. Catalog the contents of your safe-deposit box. Give a written copy to a trusted family member and note any items you are holding for someone else.



Bank or brokerage accounts. Name designated heirs or the Catholic Community Foundation as recipients of bank or brokerage account proceeds at your death.*



Charitable contributions. If you've included a gift to the Foundation in your estate plan, review the details of your gift and let us—and your loved ones—know of your intentions. This will guarantee that your wishes are carried out after your lifetime.

*State laws govern payable-on-death accounts and transfer-on-death accounts. Please consult with your bank representative or investment advisor if you are considering these gifts.
