



## GRANT DISTRIBUTIONS

The paths to inception for Catholic Community Foundation endowments start with the unique intentions of our farseeing philanthropists who establish them. Some are established by generous individuals or families who simply want to ensure a vibrant future for their parish communities. Others come to fruition when lifelong friends or school alums join together to endow scholarships to a Catholic school they attended and cherished. For others, a goal might be to honor the dedicated service of a Catholic school educator, parish priest, or neighborhood hero with a fund in their name that celebrates their Christ-like kindness.

Whatever the specific catalyst, whatever the spark that generates their interest, Foundation benefactors all have two things in common: a desire to emulate our Lord's example and to carry on His evangelizing mission however they can, and a recognition that the Catholic Community Foundation is the optimal tool to do so.

The Foundation is pleased to report that over \$4 million in grant distributions were made in FY22. We are delighted to share just some of the ways in which our fund holders are impacting our Catholic Community for the better.









- In a mission of mercy, St. Peter the Apostle Catholic Parish
  in Oakland used its distribution to offer financial assistance
  to Garrett County residents lacking the most in material
  resources, helping them cover the costs of rent and/or utilities.
- Holy Family Catholic Community in Middletown used a distribution to offset expenses incurred from its 2022 Confirmation Retreat, supporting all 24 participants on their journeys toward full initiation in the Church.
- Now in its second year of operation, Mother Mary Lange
   Catholic School in downtown Baltimore used its distribution
   to offer tuition assistance grants for children from lowincome families.
- Our Lady of the Angels in Catonsville was able to award four tuition assistance scholarships to families in need, enabling their children to attend local Catholic schools.
- Distributions to Sisters Academy of Baltimore aided the school in two distinct ways. They enabled this tuition-free school to offer its academically excellent education program to students with meager means, and helped to underwrite expenses for both the school's extended-day program and school nurse/health educator.
- St. John Parish and School in Westminster concentrated distributions it received on tuition assistance grants to families with siblings enrolled in the school and to additional families in need.

- The parish of St. Katharine Drexel Catholic Church used its distribution to fund area Catholic school scholarships.
- St. Margaret Parish and School in Belair was able to maximize
  the benefits of distributions in three ways: providing tuition
  assistance for St. Margaret School families; helping the
  poorest in the community cover the costs of utilities; and
  providing for certification, advanced coursework, and other
  professional development opportunities for teachers.
- An endowment that supports Ss. Peter & Patrick Parish in Hancock is making it possible for the parish to offer adult formation classes and Bible study groups to all who would like to participate, while the distribution from another fund was used to subsidize social and fundraising events at the parish.
- A church in Granville, Iowa is benefitting from a former resident who relocated to Maryland long ago but who wanted to ensure a steady revenue stream for his family's former parish.

## YEAR-IN-REVIEW

A year ago, as the world continued to emerge from pandemic lockdowns, economic data was broadly positive and corporate earnings were supported by the consumer. It was evident that monetary and fiscal policy efforts had served their purpose.

However, fast forward to mid-2022 and those historic levels of stimulus drove inflation to 40+ year highs. As a result, central banks began hiking interest rates which, in turn, caused capital markets to see significant declines. Stocks and bonds were both negative through the first six months of 2022, something that's only happened two other times since the mid-1970s.

Ultimately, the unfortunate confluence of these factors resulted in the CCF seeing a decline in Assets Under Management during the fiscal year, decreasing from nearly \$112.9 million to \$110.7 million and representing nearly a 1.93% loss. Fortunately, the diversification built into the Foundation's endowment helped insulate the portfolio during these volatile times. Over the trailing year, the endowment

outpaced a 70% global stock and 30% fixed income portfolio by nearly 11 percent. Investments in public and private natural resources, intended to provide inflation hedging through exposure to a broad set of commodities, as well as hedge funds, have been the main drivers of the outperformance.

Additional good news came by way of new benefactors establishing three endowments and two donor-advised funds in the CCF, increasing the total number of each, respectively, to 527 and 11.

## THANKFUL FOR HIS SERVICE AND CONTINUING HIS LEGACY THE JAMES B. SELLINGER CHANCELL OR'S

THE JAMES B. SELLINGER CHANCELLOR'S ENDOWMENT FUND

Earlier this year, James B. Sellinger, Sr. (Jim), the first-ever Chancellor of Catholic Schools for the Archdiocese of Baltimore, retired after eight years of dedicated service. To say that he left an indelible mark on the Archdiocese's Catholic School System and our entire Archdiocese significantly understates Jim's profound impact.

Many tributes and thank-yous have gone Jim's way since he announced his retirement, though he remains an active partner in supporting the mission of Catholic Schools until his successor is named. Articles celebrating Jim's tenure have appeared in the *Catholic Review* and various archdiocesan offices are finding creative ways to collectively fete him. Since his impact on the CCF and its remarkable growth has been so substantial, we are dedicating a bit of our report's "prime real estate" to celebrate Jim's contributions and to make you aware of a way you can partner with the CCF to help honor his legacy.

Jim became the Archdiocese's Chancellor for Education after a 35-year career as an IBM Corporation executive. In speaking with the *Catholic Review*, he said he was proud to have been able to continue his collaborative approach to leadership here, working closely with two superintendents, associate superintendents, and archdiocesan school board members. "It's not about me," Jim said. "I'm just one individual. The team has done a phenomenal job working with our [school presidents and principals] to sustain and grow our Catholic schools these past eight years."

"Leading our Catholic schools through historic challenges, including a global shutdown due to COVID-19," Most Reverend William E. Lori, Archbishop of Baltimore, said, "Jim helped steer an increase in enrollment and lead our students toward academic achievements that have truly defied the odds."

Jim's positive influence on our archdiocesan schools – highlighted by the opening of Mother Mary Lange Catholic School in West Baltimore – is well-documented. Less known is how instrumental he was in helping to grow the Catholic Community Foundation. Jim strongly encouraged all archdiocesan schools to establish endowments in the CCF that would both sustain their long-term viability and keep them affordable for families. His spearheading of the *Embracing Our Mission Mustard Seed Match Program* was key in helping to realize this vision and in helping enable many of our schools to safeguard their futures.

Additionally, since 2013, Jim has served on the Foundation's Board of Trustees, where the combination of his expert business acumen and his deeply felt Catholic values have made him an invaluable asset. He has agreed to continue in this role, for which we are so very thankful.

To recognize Jim's exceptional contributions, the Catholic Community Foundation thinks it fitting that we rename the current *Embracing Our Mission School Fund* as *The James B. Sellinger Chancellor's Endowment Fund*. As such, it will continue to provide the Chancellor's office with discretionary funding to address current needs, implement emerging innovations, and grow financial support for families through tuition assistance grants. With a current value of more than \$12 million, this endowment currently provides roughly \$600,000 in annual support.

# THE COMPASSION AND TENACITY OF A YOUNG TEEN GENERATES RESULTS KNOTT CARES FUND

Two years ago, at the age of 15, Scott Pawley was featured in the Catholic Community Foundation's 2020 Impact Report.

Our story then told of how Scott saw a need and responded with a steadfast commitment to seeing that it was addressed.

Through witnessing a cousin's experience, Scott understood the financial burden placed on families of children with special needs and disabilities, especially when trying to provide them with an academically excellent Catholic school education. When he discovered that there wasn't yet a way to assist these families financially, Scott acted.

To support these students and their families, Scott, a Knott Scholar both in elementary and high school, worked tirelessly to establish the Knott CARES (Catholic Academic Resource Enrichment Scholarship) Fund within the CCF, a fund that provides financial assistance to families to help cover the costs of special needs instruction at archdiocesan schools. Now, thanks to Scott's efforts, Knott CARES is fully funded.

Mimie Helm, Director of Knott Scholarship Funds, said, "I thought it might take five years or so for this endowment to become fully funded. It's remarkable how much Scott has accomplished in such a short amount of time. We support him wherever we can, but I would say that 95% of everything that has been achieved through *Knott CARES* stems from Scott."

Scott, as you might guess, is pleased with this success. "I'm very excited," he said. "My family and I spent a lot of time sending emails, speaking at parishes, and doing fundraisers. Consequently, in the 2023-24 school year, we'll be able to start making distributions. The entire experience has made a really deep, personal impact. And, since the fund is needs-based, it will help those families who wouldn't otherwise be able to afford Catholic school."

Dr. Donna Hargens, Superintendent of Catholic Schools for the Archdiocese, is grateful for students like Scott who are willing to pay their good fortune forward. "Scott's tenacious commitment to helping others," she said, "is a testament to the transformational quality of a values-oriented, Catholic education. His compassion and thoughtfulness are an example to us all."

Mimie Helm echoed that sentiment, "Part of Henry Knott's vision for the Knott Scholars is that they become leaders in the Catholic community. Scott has done exactly that."

## IN MEMORIAM SAMUEL W. CHAIRS, JR.

Samuel W. Chairs, Jr., a major benefactor of and longtime friend to the Catholic Community Foundation, passed away in August of this year.

A successful business owner and devoted husband and family man who cherished time spent with his family, Mr. Chairs established numerous funds within the CCF in their names, benefitting a variety of institutions and initiatives, including, among others:

Honoring their wishes, many of Mr. and Mrs. Chairs' descendants have become administrators of the funds he established, honoring his and Patricia's deeply felt faith and generous spirit of service.

Additionally, Mr. Chairs served on the CCF's Distribution Committee from 2007-2011, thus endowing the CCF with not only his sacrificial contributions, but also with the gifts of his invaluable time and expansive reserves of investment acumen and business expertise.

The Catholic Community Foundation is most appreciative to have been able to count Mr. Chairs as one of our strongest advocates and profoundly grateful for the Chairs family's continued support of our mission.
