From educational support to parish life, and from social services to spiritual formation, each endowment and grant distribution has the power to uphold and nurture our family of faith in lasting and profound ways.

HONORING A SINGLE PARENT'S STRENGTH AND SACRIFICES The Regina Cecilia Jenkins Memorial Endowment Fund

When those who knew her speak of Regina "Jean" Jenkins, their voice invariably begins to quiver from the raw emotion the story this remarkable woman's life evokes.

David Jenkins, her son, spoke to us at length about Jean, her incredible life, and his family endowment fund that her life inspired. This fund is honoring her dedication and hard work by providing single-parent children in the Archdiocese of Baltimore with financial assistance to attend an archdiocesan Catholic school.

Jean Jenkins was no stranger to adversity. Growing up in a working-class family that fell on tough times, she shouldered the responsibility of supporting her family when her parents became ill. Her brother later went to live with relatives in Texas, leaving Jean to navigate life's challenges on her own. "Despite her brilliance," David said, "circumstances forced her to prioritize survival over personal aspirations."

Her resilience deepened as she became a single mother in the late 1970s. "She worked tirelessly to ensure we had the opportunities she lacked," David said. "From taking odd jobs to pursuing her college degree in her forties at Morgan State University—where she often brought me to class—Jean epitomized determination."

A devout believer in Catholic education, Jean worked three jobs to send David to Catholic schools, knowing they would instill in him a foundation of faith, discipline, and service. Her sacrifices were not made in vain. "I excelled," David said, "and I developed a strong work ethic, inspired by my mother's example." He worked after school to help with family finances and became deeply connected to his Catholic community. When Jean passed away last June, David and his wife, Michelle, knew they had to honor her legacy. "We wanted to establish an endowed fund with the Catholic Community Foundation," David said, "to help children of single-parent homes like mine."

With a fervent desire to extend his mother's spirit of selflessness and perseverance to others, David and Michelle worked with the Foundation to establish *The Regina Cecilia Jenkins Memorial Endowment Fund*. They found the process seamless and easy. "Terry [Brashears, Assistant Director for the Foundation] walked us through everything. The Foundation established the fund within two weeks of our alerting them to our decision."

The Regina Cecilia Jenkins Memorial Endowment Fund will mean the world of difference to singleparent households in our community.

"While all Catholic school families make great sacrifices," Dr. Donna Hargens, Superintendent of Catholic Schools for the Archdiocese, said, "single parents can face unique challenges. Endowment funds like this provide them and their children access to a 21st century education that can break barriers. Endowments like *The Regina Cecilia Jenkins Memorial Endowment Fund* offer not only financial support, but also hope—helping to build futures grounded in faith, perseverance, and the promise of opportunity."

"Mom changed the trajectory of our family tree," David reflected, a message he was able to share with Jean prior to her passing, "and we felt an urge to help uplift other families similarly in her honor."

CELEBRATING FAMILIAL BONDS TO A BELOVED PARISH AND SCHOOL

The Sparr Family Endowment for Catholic Education Fund

The legacy of the Sparr family is woven deeply into the fabric of St. Stephen Parish and School in Kingsville, where generations have been baptized, married, and educated. Now, through the newly established Sparr Family Endowment for Catholic Education Fund, this legacy will continue to make a difference in the lives of students at St. Stephen School for years to come.

Karen Arnold (formerly Sparr), baptized at St. Stephen, had always felt connected to the school and parish, even after relocating from the area. Both her parents attended the elementary school, and Karen's mother was a member of one of the last graduating classes of St. Stephen High School.

Karen and her husband, Lee, further strengthened this family history to Catholic education when they began raising their own children. "I wanted our children to have the same opportunity for a Catholic education that I did," Karen said. "The values and moral foundation it provides are so important, and Catholic schools help instill these in a way that secular schools cannot."

The idea for the fund emerged after the passing of Karen's father, Philip Terrence "Terry," in 2022. His strong connection to St. Stephen, along with his and his wife's shared belief in the power of Catholic education, inspired Karen and her daughter, Jacqueline, to establish the endowment in his honor. The fund provides tuition assistance grants to students at St. Stephen, helping families who may otherwise face financial barriers to a Catholic education.

Karen and Lee had been quietly supporting Catholic causes for years, but their philanthropy had always been a private matter. It was only recently that they shared their story with others, recognizing that this new fund could make a broader impact.

Jacqueline "Jackie" Guice, Karen's daughter, has also long been a strong proponent of Catholic education. Her experiences at Mount de Sales Academy, where theology studies were both deep and thought-provoking, shaped her view on the importance of faith and education. "Seeking truth through prayer is a lifelong process," Jackie said. "That's what Catholic education taught me, and it's what I want for other children."

For the Sparr family, this endowment is a way to ensure that the values of Catholic educationcentered on Christ, grounded in a strong moral code, and reinforced with theological understanding—continue to thrive. As Karen explains, "Catholic schools today seem to have a sturdier underpinning in the faith. They are dynamic and theological, not just 'rote' as it had been in the past. It's the best of both worlds."

"We deeply appreciate that St. Stephen has meant so much to the Sparr family that they have committed to seeing it continue to thrive for future generations of students," Marianne Kozlowski, Principal of St. Stephen School, said. "Our Catholic community is very fortunate that so many, like the Sparrs, are profoundly engaged. Their generosity ensures that students of today and tomorrow will benefit from the strong faithbased education our school offers, and reflects the commitment of Catholics in the Archdiocese of Baltimore to nurture and sustain our beloved schools and values."



Over fiscal year 2024, the Catholic Community Foundation's portfolio increased from \$112.4 to nearly \$115.9 million. Importantly, with 8 new funds established, this brought the Foundation's total amount of endowment funds to 541, and donor-advised funds to 10.

Equity markets experienced a continuation of strong performance from 2023, which led to new highs in major domestic indices and strong returns globally. From an economic perspective, real GDP came in below expectations in the first quarter of 2024. Inflation has moderated but remains above the Federal Reserve's preferred two-percent level, which has justified keeping interest rates at current levels. Domestic growth was supported by consumer spending, which slowed marginally at the beginning of the year, having been above trend for an extended period. Employment has remained relatively healthy according to the monthly Bureau of Labor Statistics data.

Ultimately, however, the Catholic Community Foundation's endowment underperformed its policy benchmark by 0.7 %. This was largely due to private equity and venture capital investments, which are valued on a one-quarter lag and have trailed the strong public equity markets. While these investments tend to be volatile within shorter time horizons, they have been the primary source of the Foundation's outperformance over the long term. Diversifying and inflation-hedging investments such as hedge funds, private natural resources, and real estate, contributed positively to the Foundation's relative performance during fiscal year 2024.

GRANT DISTRIBUTIONS

The Catholic Community Foundation is pleased to report that more than \$5 million in grant distributions were made in FY24. Below is just a small sample of how these distributions from Foundation endowments are strengthening our Catholic community.

Archbishop Curley High School's distribution is helping to cover the costs of general school needs, so these costs are not added to the school's tuition and, thus, not passed on to its school families.

Bishop Walsh High School is utilizing a distribution for tuition assistance grants, expanding access to this excellent school for families who, otherwise, could not consider it.

Funds distributed to **Catholic Community of South Baltimore** are helping the parish augment opportunities for evangelization through gatherings at its retreat house, pilgrimage walks, Christmas caroling events, and other occasions designed to enfold families more deeply into parish life.

Church of the Nativity's distribution is making it possible for the parish to purchase new equipment that will improve the broadcast quality of its live-streamed Masses.

Divine Mercy Parish used a distribution for multiple outreach initiatives: to help supply local food pantries; to support Archway Station in aiding children and young adults with disabilities; to strengthen local care centers for seniors; and to assist expectant mothers through 1st Way Pregnancy Center.

John Carroll School in Bel Air is setting a Christ-centered example for its students by providing outreach to St. Rose of Lima School in Haiti with a distribution, while a second distribution is helping underwrite a scholarship awarded to an incoming student with the best application essay.

Monsignor Slade Catholic School used a distribution to build a more secure vestibule.

A Notre Dame Preparatory School distribution is empowering the school to offer emergency assistance to families facing acute financial hardship.

A distribution to **Our Lady of the Mountains** enabled the parish to offset expenses of a new sound system for its choir loft.


Children in the Catonsville community are benefitting from a distribution to St. Agnes, which the parish is using to support its popular summer camp program.

Teachers and staff at St. Mary's Schools in Annapolis are benefitting from advanced coursework and training that a Catholic Community Foundation distribution is funding.

St. Vincent de Paul's distribution is strengthening its 22 programs of outreach, while Catholic Charities' Our Daily Bread Employment Center is using a distribution at its discretion, where it identifies the greatest need.


More than 15 archdiocesan parishes are using distributions they received to maintain and beautify their memorial gardens.



SUPPORTING SEMINARIAN FORMATION AND ADVANCED STUDIES FOR PRIESTS The Smith and Wendelken Family Endowment Fund

Joe and Kathy Smith were at a turning point in their philanthropy, a time for reflection, not only on their personal faith but also on the future of the Church. From a practical perspective, they recognized a need that struck at the heart of their family's faith journey—they needed priests to administer the sacraments now, and their children and grandchildren would need them in the future too.

With a growing awareness of the challenges facing the priesthood, the Smiths set out to make a meaningful difference. "We were re-evaluating our charitable giving," Kathy explained. "And from a selfish standpoint, we saw that priests were essential for our lives—and would be for generations to come."

Kathy's background as an executive at a non-profit organization provided increased insight. She understood the critical importance of financial support for seminarians and priests. To that end, the Smiths established *The Smith and Wendelken Family Endowment Fund* in the Catholic Community Foundation, a fund designed to support both seminarians and priests in need of financial assistance for their education and continued formation.

"There was no grand inspiration from any one priest," Joe said. "It wasn't about any individual. It was about being intentional with our giving and making a difference for the Church's future." The process of establishing the fund was surprisingly simple. Joe and Kathy met with Jim Edwards, then-Director of the Foundation, and within two weeks, the fund was set up. "It was very easy," Joe said. "We were signing the agreement in no time."

The Smith and Wendelken Family Endowment Fund provides vital resources not only for seminarians just beginning their priestly journeys, but also for priests already in ministry seeking advanced studies. "We wanted all priests and seminarians to benefit from our fund," Kathy added. "It was about strengthening the Church today and into the future."

Father Steven Roth, Director of Vocations for the Archdiocese, underscored the profoundly beneficial impact such endowments have on the Church. "By lessening financial burdens on our seminarians and priests," he said, "endowments like *The Smith and Wendelken Family Endowment Fund* help ensure that the Church continues to thrive with an ever-rich pipeline of strong, dedicated leaders."

For anyone considering making a similar commitment, Joe offers a simple piece of advice: "To borrow the Nike line, 'JUST DO IT'...but also, pray about the decision. Can you commit to establishing a fund and to continuing to support it?"

Their decision to establish *The Smith and Wendelken Family Endowment Fund* took on even more significance later when Joe and Kathy learned that three of their grandsons—brothers—were all in the process of discerning calls to the priesthood, a revelation that further reinforced their decision.

As they reflected further, the Smiths were quick to acknowledge that the decision to establish the fund was clearly God's plan. "Ultimately, it wasn't our idea," Kathy said. "It was His."



ASSISTING SEAFARERS FAR FROM HOME The Monsignor FitzGerald Fund for the Apostleship of the Sea

In 2013, Reverend Monsignor John FitzGerald took a visionary step that would create a lasting impact on the Apostleship of the Sea (AOS) ministry in the Archdiocese of Baltimore. A devoted Navy Chaplain for nearly 30 years, who retired with a rank of Captain, Monsignor FitzGerald understood the unique challenges faced by seafarers isolated from their families, often in need of spiritual care, and navigating difficult lives on the high seas.





His deep commitment to this ministry led him to establish *The Monsignor FitzGerald Fund for the Apostleship of the Sea*, a lasting revenue stream to support AOS's vital work, within the Catholic Community Foundation.

As Monsignor FitzGerald's fund has grown over the years, it now provides distributions that directly benefit the seafarers AOS serves. "Monsignor FitzGerald was the right person at the right time for this job," Andy Middleton, Director for the AOS said. "He was a wonderful fundraiser and a people person, and, importantly, someone who genuinely cared about seafarers and understood the necessity of creating long-term financial stability for this ministry that aids them."

The Monsignor FitzGerald Fund for the Apostleship of the Sea, built up over the past decade, serves as an auxiliary fundraising source for AOS, sources that also include donations from loyal donors, suggested contributions from participating ships, and annual fundraising events.

This year, distributions from the endowment played a key role in AOS's response following the collapse of the Francis Scott Key Bridge, offsetting the expense of SIM cards for the stranded *Dali* crew, so they could stay connected with their families at home. Distributions also helped pay for a day of sightseeing



for crew members in Washington, DC, offering them some much-needed respite. "These are the kinds of moments we want to create—where seafarers remember that, in their time of need, the Archdiocese of Baltimore saw, appreciated, and cared for them. They come away thinking of the Port of Baltimore, as ministered to by the Apostleship of the Sea, as a safe haven," Middleton said.

Looking to the future, Middleton has ambitious goals for Monsignor FitzGerald's fund. "We will use distributions to help seafarers stay connected to their faith," he says. "Whether providing Catholic reading materials, prayer cards, or supporting outreach efforts to non-Catholic seafarers, we're looking to evangelize the Catholic faith in a way that speaks to their hearts."

"The Monsignor FitzGerald Fund for the Apostleship of the Sea is a perfect example of the Catholic Community Foundation working as intended," Kim Montgomery, Executive Director for the Foundation, said. "Monsignor FitzGerald's desire to create lasting revenue for the Apostleship of the Sea has come to fruition. The AOS and seafarers across the globe are benefitting from his acute foresight of many years ago."

Through *The Monsignor FitzGerald Fund for the Apostleship of the Sea*, Monsignor FitzGerald's legacy of compassion for the world's seafarers and their families, will long endure.
